



Penketh Primary school Key achievements to date until July 2020:	Areas for further improvement and baseline evidence of need:
We have steady improvement in swimming proficiency due to our continued use of sports premium to top-up the curricula swimming provision on offer	Increasing club participation within all year groups, providing clear and planned interventions for those children who are identified as not active will increase the number of children taking part in regular physical activity and the range of sports they have the opportunity to experience.
As a school we have catered for our local needs regarding sporting links and participated in inter school competitions both at home fixtures and away	An improved strategy for reporting on and publicising sporting events will increase school participation.
Prior to the national lockdown we had amassed our highest participation rate for extra curricula clubs since we began monitoring, we also boasted a high percentage of 97% pupil premium attendance and over 75% SEND participants.	Pupils will benefit from having their PE provision quality assured So they are having the highest quality PE delivered to them. Achieving the 'Sainsbury's Game Silver Mark' for whole school participation in inter and intra school competitions will improve competition participation Increasing leadership opportunities within school, including using sports leaders as a part of Intra competitions across the school will raise our student's subject knowledge and independence, providing key opportunities to officiate And run competitions within school.
	The impact will be measured through evaluation of the number of Intra competitions delivered (we have set ourselves a target of 6 intra competitions to complete this year) Ensuring sustainability within our current PE and School Sport provision will be achieved through the continued professional development of our staff; we are investing in projects that will continue to improve our sport provision.




